### 1. Maintenance


[CR 14104] To enhance the effectiveness of Defects and Claims management in the system, the **Defects** and **Claims** sub modules will now include the 'Parent' of damaged components.

With this update, when a child component is selected as a defective component, users will be able to easily identify the parent component to which this child component is referring. The screens listed in the table below have been updated following this enhancement:




### 2. Materials

[CR 13793] Updated the Location Manager access right to cater to Vessel users that can update material inventory by location on the Location Manager screen without having the right to modify the location name and description.

The updates implemented in this latest enhancement are:

Location Manager access right split into two:

Access Right	Description
Location Manager	Depending on the permissions granted, users may view, update, add, and/or delete stock locations, components, and documents on the Location Manager screen. <b>Note:</b> To make changes to the <b>Materials</b> tab, users require the <b>Material - Update Location</b> access right to connect/remove
	materials to and from a location and the <b>Stock Update</b> access right to update the stock for each material category (Spare Parts, Provisions, Consumables, Tools, etc.).
Location Manager - Update General Tab	If the <b>'YES'</b> check box is selected for a User/Role, the User/Role will be able to make changes to the <b>General</b> tab on the Location Manager screen. This is a new access right.

### 4. Materials

- [79977] Fixed the negative stock values showing for the Closing Balance in the Material Stock Value FIFO Report caused by duplicate entries in the material consumption data.
- [79976] Fixed the incorrect calculation applied in the Material Stock Value FIFO Report, which derived the Quantity and Values for the Opening Balance, Purchases, Consumption, and Closing Balance based on average price instead of the FIFO principle.

### 5. Procurement

[81752] Resolved an issue where the Order Number in the Purchase Invoice Checklist report was missing when the Exclude Cancelled Invoice check box was selected and the status is Transferred to Accounts.

This issue only affected invoice line items that were connected to Purchase Orders where the invoice status is Transferred to Account or later.




